### Outer Boundary Demarcation Finalized

After more than 3 months of work, the demarcation of the outer boundary for the Ayitepa Wind Farm was successfully finalized the week before Christmas. The boundary demarcation started in September on the eastern side of the project area and proceeded clockwise around the project perimeter. The outer boundary consists of a total of more than 150 pillars.

The surveyors from Rudan Engineering Ltd., the company that has carried out the whole demarcation, have been recording the coordinates of the last pillars with a static GPS. Following the field work, site plans will be prepared and appended to the already signed Land Lease Agreements.

Due to careful introduction of Health and Safety regulations on site, not a single issue had to be reported during the whole demarcation period. Although there were some disagreements between the clans regarding the land boundaries, all problems were resolved peacefully. Community Liaison Officer Francis Tsatsu Owulah says that he is grateful to the Landholders, the NTC Committee members, especially, those who joined in the field for the land verification exercise, Rudan Engineering and the field workers for supporting Upwind in achieving this feat.

### PPA Addendum Signed

On 09<sup>th</sup> May 2016, the Power Purchase Agreement for the 225 MW wind farm at Ayitepa was signed at the Headquarters of the Electricity Company of Ghana Ltd. (ECG) in Accra. A few amendments were required to that version of the PPA, which were negotiated between the ECG and us during the past months.

The changes to the PPA include the agreement for a 20-year fixed tariff. Signing of the amendment took place on 22<sup>nd</sup> November 2016 at the headquarters of the ECG in Accra.

This is the first PPA signed for a wind project in Ghana.



## Wind Park Year 2016 in Retrospect

The 2<sup>nd</sup> Community Engagement Event serves to inform the local communities.




### May

The Customary Rites Performances praise the gods and ancestors of the land.




### September
